




In order to be Green or Blue overall on the SPF, a school must be Green or Blue on the Academic Gaps Indicator.











- 6) This chart shows the Median Growth Percentile (MGP) of ELL students on ACCESS. The "Meets Expectations" benchmark for the 2018 District SPF is an MGP of at least 50.
- 7) This graph compares the performance of specific subgroups of students on 2017-18 CMAS: PARCC relative to their peers within the school and throughout DPS.
- 8) This graph reports status results for the ACCESS assessment. These results are not used for accountability purposes, and instead used to understand the specific ELL population that the school is serving.
- *Note: Due to assessment, methodology, and scoring shifts, ACCESS data should not be compared year over year.


5 Percent of ELL Students "On-Track" on ACCESS







